## 2. DEPUTY DIRECTOR-FINANCE (MU5) (RE-ADVERTISED)

The Deputy Director-Finance shall report to the Director of Finance and Investments. His/her major role shall be to manage financial and material resources of the University.

#### **Duties**

- b. Developing, reviewing, implementing and monitoring sound financial control mechanisms.
- c. Reviewing and monitoring implementation of sound financial risk management mechanisms.
- d. Preparing financial statements and management accounts, variance analysis and explanatory notes in accordance with applicable accounting standards.
- e. Costing project works and other services offered to customers in liaison with relevant sections.
- f. Coordinating the relationship between the University and external auditors including other bodies with the rights to audit/inspect University's financial information.



- g. Overseeing the processing of salaries, advances and other payments including statutory obligations.
- h. Monitoring and preparing institution's cash flows and bank reconciliations.
- Maintaining insurance records, claims and fixed assets registers.
- j. Allocating work and appraising staff.
